- Heat Cards/Score Sheets, Ribbons and League fees may all be paid on 1 check made out to the League; however, please itemize so that treasurer can give appropriate credit in bookkeeping.
- Hasty came in less expensive and much more cooperative and communicative than Carriage in the Ribbon pricing; therefore, needed balance of ribbons for year were ordered through them. Small difference in size 6" vs. 6.5".
- All ribbons which were turned in last month had been counted, bundled and redistributed amongst all teams.

- Timers must not put hand out to reach for incoming swimmers – hand must rest on edge of pool only.
- Stroke Judge must check appropriate box for a DQ, initial and add any comments if possible, coach swimmers of DQ only if able to consistently do so for all.
- League Reps to try and coordinate stroke judges to all be on same page (CONSISTENCY)!
- Any future Stroke Judge Clinic's will be posted on website and e-mail sent to Team Reps. St. Peters will be having 1 the first week of June.

- For All County T-shirts, Team Rep keeps track of their swimmers but any extras must be ordered through website – will be set up with Winning Streak.
- Exhibition swimmers are not limited but must use white cards.
- Roster numbers were discussed and verified by Danielle with those Reps present.
- Julie Hill of Johnny Macs has 2 more seasons of suits, since no other bidders came forth.
